What is the Curling Registration and Management System (CRMS)

The Curling Registration and Management System (CRMS) extends today's technology to Member Associations and Curling Clubs across the country, providing them with a full range of web-based tools to accept curler registrations, manage and communicate with your curlers, accept online payments, and leverage full reporting capabilities.

Key Features of the System

- Completely web-based system, accessible via web browser
- Tiered access (Curling Club, Member Association, Curling Canada)
- Data access controls and usage restrictions
- · Curling Club Online Registration
- **ZERO COST** to Curling Clubs or Member Associations

WHAT WILL IT LOOK LIKE?



Much like any other web-based management system, the Curling Registration and Management System will include:

- Stand-alone front-end user forms that are branded with the Curling Club and Member Association
 - Simple website integration for Curling Clubs and Member Assoc.
 - Secured with SSL certificate
 - Hosted on Curling Canada Technology Infrastructure
- Backend administrative web application
 - Management of registration forms
 - Curler Management Tools
 - Reporting and Accounting Export Tools

CURLING CLUB REGISTRATION



Web-based system that provides Curling Clubs with online registration capabilities for their curlers.

- Web-based system
- · Simplified registration forms for curling membership, special event, etc.
- Customizable membership fee structures
- Add-on Product/Item capabilities (i.e. shirts, lockers, etc.)
- Clearly displayed Member Association and Curling Canada fees
- Online Payment Processing capabilities
- Funds are automatically deposited into the Curling Club, Member Association and Curling Canada bank accounts after they have been cleared by the processing gateway.

SECURITY AND PRIVACY



A secure and trusted service for our members and yours.

- SSL Certificate for encryption of all data being transmitted
- Two-factor Authentication for logins to the administrative backend
- Curling Participant information will not be used for direct marketing purposes by the Member Associations or Curling Canada without the participant's consent.

- With online payment integration, funds are automatically deposited into the Curling Club's existing bank account, and reporting and fee remittance to their Member Association and Curling Canada is fully automated.
